School Resource Officers Revisited

RECOMMENDATIONS

R1: SRO Programs in Marin County should be retained or expanded where they now exist. SRO programs should be established to cover those school districts where they do not exist.

Response:

Option A

This recommendation has been implemented.

Our district currently has an SRO program with the (insert law enforcement partner/s) and expects it to be retained.

Option B

This recommendation will require further analysis.

Though we do not have an SRO program, our district works in consultation with our law enforcement partners regarding the safety and security of our schools, and, we feel that the current level of services is meeting our district needs.

We would support discussions about the potential for future program expansion as resources are become available. We also support exploring how we can utilize current resources allocated by school and law enforcement agencies in the most effective way possible, for example, more closely aligning the work of our campus supervisors with our local law enforcement partners through additional training and professional development which can be provided on a countywide basis.

R2: Municipalities, school districts, and law enforcement agencies in Marin County should make SRO programs a high budgetary priority.

Response:

Option A

This recommendation requires further analysis.

Our district understands that the safety and security of our students is our primary responsibility and a very high priority. We are always willing to work with our local partners to support that priority. The designation of funding for an SRO programs may not be possible given budget constraints. We will, however, work with the Marin County Office of Education and law enforcement partners to determine if grant funding may be available.

A status report will be provided by November 23, 2019.

Option B

This recommendation will not be implemented.

Our district understands that the safety and security of our students is our primary responsibility and a very high priority. We are always willing to work with our local partners to support that priority. At the current time, budget constraints would prevent us from committing funds to a new SRO program.

R9: School districts should take the lead in working with their city councils and law enforcement agencies to employ and maintain a sufficient number of SRO's.

Response:

Option A

This recommendation has been implemented.

Our district currently receives SRO services in partnership with the (insert law enforcement partner/s).

Option B

This recommendation has been implemented.

Though our district does not have a SRO program, we work closely with our local law enforcement partners and municipalities regarding school safety and security and we

feel that the current level of services is meeting our district needs. We would support discussions about the potential for future program expansion as resources are become available.

R10: School districts and municipalities should explore funding sources such as grants, bond issues, special taxes and other sources.

Response:

Option A

This recommendation is being implemented.

We agree with the Grand Jury's recommendation to seek additional resources as appropriate. This could include partnering with our local partners on grants, as well as participating in countywide funding opportunities for school security. We will continue to collaborate with the Marin County Office of Education to identify and apply for grant funding for school safety and security

R11: School districts and municipalities should consider sharing the costs and services of SRO Programs.

Response:

Option A

This recommendation requires further analysis.

The safety, health and well-being of our students and staff is a foremost priority for our district and we are always willing to work with our local partners to support that priority. At the current time, budget constraints would prevent us from committing funds to a new SRO programs. However, we supporting working with school districts countywide, the Marin County Office of Education, and law enforcement partners to explore the potential for new funding.
