Join trustees, students and superintendents from Marin County at the annual JLAC (Joint Legislative Advisory Committee) Seminar to meet with legislators, key staff, and education leaders in Sacramento on January 17, 2018.

The purposes of the JLAC Seminar are:

- To receive updates and information on pressing legislative and budget issues regarding education.
- To maintain contact and develop relationships with our legislators, including Assemblymember Marc Levine and Senator Mike McGuire, as well as other individuals and groups which affect education policy, legislation and the budget.
- To develop a team of Superintendents, Board members and student advocates who promote the interests of all children in California as well as the specific needs of students in Marin County while impacting the legislative process.

Participants will hear from our legislators, legislative staff members and other leading figures who will provide the most updated information and insights. Speakers will be asked to address issues identified by JLAC as priorities for our school districts. An agenda with speakers and topics will be provided in early January.

The anticipated cost for the complete day is \$70.00 per person which includes seminars, lunch, materials and bus transportation. We are asking for a confirmation of whether or not you are interested in utilizing bus transportation. A final decision on the bus will be made once we have a final count and see if there are enough riders to warrant the expense.

The 2018 Marin County Legislative Action Seminar is planned and coordinated by the Ball/Frost Group, LLC, our Marin County Legislative Consultant in Sacramento, in conjunction with the Marin County Joint Legislative Advisory Committee. 
