1. The regular meeting of the Marin County Office of Education Personnel Commission was held at the Marin County Office of Education, 1111 Las Gallinas Avenue, San Rafael, CA on Monday, December 14, 2009.
2. Mr. Pollock convened the meeting at 5:00 p.m. The staff was represented by Ms. Mary Jane Burke, Ms. Mary Batchelder and Ms. Christie Colón. **Call to Order**
3. Present for the meeting were Commissioners Bill Bridges, Catherine McKown and Pat Pollock. **Roll Call/Guests**
4. M/s/c McKown, Bridges to approve the Agenda. **Agenda Approved**
5. Mr. Pollock invited public comment on items not on the agenda:
 - Marin County Superintendent of Schools Mary Jane Burke informed the commission that the San Rafael City Schools and Novato Unified School districts are taking back their non-intensive preschool program for 2010. As a result, the Marin County Board of Education voted to approve layoff resolutions. Ms. Burke also reported further layoff resolutions by the Marin County Board of Education.
 - Ms. Burke announced the resignation of the Personnel Director at the end of the 2009-10 year. Ms Burke discussed her interest in considering an internal candidate as replacement, and invited the Commission to jointly consider this as a plan for 2010-11 staffing. The Commissioners requested that an item to discuss the staffing plan be put on the January meeting agenda. In addition, they asked that Tracee Edmunds, Business Services Manager, attend the January meeting for the purpose of an informal conversation of her interests as an internal candidate.**Public Comment**
