Alicia Ncho Oguie, a parent of a student in the Novato Unified School District, shared information regarding the need for developing inclusive playgrounds in Marin County schools, and that it was currently Inclusive Schools Week. Alicia's daughter, Emma, shared that she has a sister with autism, and there is a need for developing inclusive playgrounds.

Lena Godfrey, parent of a student in the Reed Union School District, shared that it was currently Inclusive Schools Week and there is a need to recognize inclusion all year. She shared that she was frustrated that the Reed Union School District was not currently making changes to its current playground structures and would like districts in Marin County to pledge to build inclusive playgrounds.

agencies (LEAs).

The SELPA Director shared information regarding the status of the 2023 CDE Compliance and Improvement Monitoring (CIM) Plans for the twelve (12) identified member local education agencies (LEAs) in the Marin County SELPA required to complete a Plan. Twelve (12) local education agencies developed a multi-year CIM Plan that includes high leverage strategies and meaningful activities to support student outcomes. The SELPA submitted assurances to the California Department of Education verifying that it assisted and supported each LEA in the development of the Plan and will continue to assist and support each LEA throughout the monitoring cycle accordingly.

5.3 Fall Census Reporting

The SELPA Director shared the activities the department has engaged in this school year to support member LEAs with meeting the California Longitudinal Pupil Achievement Data System (CALPADS) Fall 1 certification deadline on December 15, 2023. Activities included website enhancement, professional development workshops, phone consultation, email consultation, and digital resources.

The SELPA Director presented information regarding the work of the Marin County SELPA's Special Education Advisory Committee (SEAC). The SEAC is hosting its first annual Parent and Child Resource Fair on March 23, 2024 at the Marin County Office of Education. Representatives for a variety of different local agencies will be in attendance to share information and resources with families of children with disabilities. The SELPA Director shared that the next SEAC meeting is scheduled for January 24, 2024.

To continue to advance the implementation of the Unified Sports program, coaching stipends will be offered to each participating school district. The Marin County SELPA shall reimburse the participating school districts using the formula below:

Each school district participating in the Special Olympics Unified Sports Program shall be eligible for up to four (4) coaching stipends for the Unified Sports basketball season and three (3) coaching stipends for the Unified Sports track and field season. Each district participating in the Special Olympics Unified Field Day Sports Event shall be eligible for up to two (2) teacher stipends.
